

MINOX Total Coverage Warranty

Terms and Conditions

Congratulations on the purchase of your MINOX product. By registering your purchase, you will gain the full benefits of our MINOX Total Coverage Warranty. This extraordinary plan provides protection against manufacturing defects, functional failures, or any accidental damages to the covered product, such as breakage, water damage, or accident.

This warranty covers the following product lines only:

ZE, ZA-HD and ZV Rifle Scope Lines
APO HG, HG, BL, BD, BV, BF, BN Binoculars
MD Spotting Scopes
Oculars for MD 62 Spotting Scopes

All other MINOX products not included in the above list are exempt from the MINOX Total Coverage Warranty.

IMPORTANT: Your MINOX product must be registered within 30 days from the date of purchase to obtain the exclusive MINOX Total Coverage Warranty. Be sure to register your product online at www.minox.com/usa/warranty.

1) The MINOX Total Coverage Warranty provides for repair or replacement for any problem that prevents the proper optical or mechanical function of the registered product. Cosmetic or other signs of normal wear and tear on external surfaces including lenses are not considered as affecting optical or mechanical function of the product. Occurrences of loss, theft, fire, and deliberate damage are not covered by this warranty.

2) Specifically excluded from the MINOX Total Coverage Warranty are all accessories such as cases or covers, rain guards, lens caps, etc. which might be included in the scope of delivery, as well as all analog or electronic devices integrated into the product such as a digital or analog compass or illuminated reticle.

3) Following registration of your purchase, your product is covered for 30 consecutive years of ownership by the original purchaser. The MINOX Total Coverage Warranty can be transferred to a second owner, but is then limited to the remainder of the 30 years from the date of first the first registration – e.g. if the first owner sells the registered product after 10 years, the second owner will get a maximum of 20 years Total Coverage Warranty. For validation purposes, the first owner must verify their registration of the product. The second owner must prove the purchase and re-register the product per email to MINOX. All further owners are exempt from the MINOX Total Coverage Warranty.

In the case of damage or defect, **MINOX GmbH, Germany** will repair or replace the registered product at no charge to the original or second owner respectively. To obtain required service, residents within the **USA** can send the products to **Blaser USA, Inc.** or directly to **MINOX GmbH, Germany**. However, residents of **Canada** must send the MINOX products directly to:

Please note: repairs sent from Canada will not be accepted and will be returned at the sender's expense.

4) Product replacement, if required, will be by a functionally identical or like-featured product that may be either new or refurbished as determined by **MINOX GmbH, Germany**.

5) In the event that any devices or accessories other than those distributed or officially recommended by MINOX have been attached or connected to the product in such a manner that the original factory construction has been altered, any damage resulting to the product will not be covered by the MINOX Total Coverage Warranty.

6) In the event any individual, firm, shop, etc. other than those specifically authorized by **MINOX GmbH, Germany** (or its authorized agents in the United States) tampers with the product in a manner other than required by MINOX for normal operation of the product, any damages occurring will not be covered by the MINOX Total Coverage Warranty.

7) Recovery under any implied warranty of the merchantability and/or fitness that you may have hereunder is limited to repair or replacement of the product as provided above.

8) Any such implied warranty of merchantability and/or fitness is limited to the duration of this MINOX Total Coverage Warranty. This warranty does not obligate **Blaser USA, Inc.** or **MINOX GmbH, Germany** to reimburse the original purchaser or any user of the equipment for any expenses, loss or other incidental or

consequential damages which may arise in connection with any use of the equipment. Regardless if some states do not allow limitations on how long an implied warranty lasts, or if some do not allow the exclusion of limitations of incidental or consequential damages, the maximum warranty period is 30 years for the original owner or a maximum of 15 years for the second owner.

9) The MINOX Total Coverage Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

10) To gain the benefits of the MINOX Total Coverage Warranty, your product purchase must be registered within 30 days of the date of purchase. In the absence of registration, products requiring service can be sent to **Blaser USA, Inc.** or directly to **MINOX GmbH, Germany** and must include a copy of the original sales receipt. Warranty coverage for such non-registered products is limited to two years after purchase, which provides only for product repair or replacement in instances of manufacturing or material defects.
